## Notes

- The price is meant per person with minimum 2 persons.

- Payment has to be made as booking confirmation, when checking the availability of the chosen accommodation.

## Visitor's Tax

- 5\*/4S\*/4\* Hotels € 1,80 per night
- 3\*/3S\* Hotels € 1,50 per night
- 2\*/1\* Hotels or Hotels with no rating € 1,20 per night
- Other accommodation (eg. B&B, farmhouse inn,...) € 1,00

EXEMPTIONS: Children up to the age of 14 are not required to pay tax

## Cancellation policy

The person willing to cancel a reservation has to send to the accommodation a written notice via fax or email. If this notice arrives to the reserved accommodation 31 days before the beginning of the stay, the person will be entitled to the refund of the amount paid during the booking procedure, net of the bank/post expenses supported by the accommodation (duly reported). In case the cancellation occurs after this deadline (from the 30th day before the arrival of the stay) or in case it never occurs, the reserved accommodation will be entitled to withheld the entire amount pre-paid. In case the period of the stay is changed (in agreement with the accommodation) it will be considered valid as cancellation of the first reservation made.
